1. Approval of on-call proposal with Kimley-Horn and Scott Scarfone

Scott Scarfone has worked with the Town through Oasis Design Company. This company has recently merged with Kimley-Horn. This on-call contract allows for the same services as before, just through the new company. The Town is not obligated to use his services, but if we do, the contract will already be on file. One potential project for Scott is to review and update the Town of Sykesville's Landscape Manual used for the development review process.

- 2. Authorization to apply for FY 18 SHA Recreational Trails grant
 This grant will be used for the repair of approximately 2200 linear feet
 of the Linear Trail south of Kalorama Road. Repairs to this stretch
 will greatly improve the trail and will make it more favorable for a
 walk or a bike ride. It is not feasible to reconstruct the trail to meet
 ADA requirements, due to the grade, so the Town will have to work
 with SHA to request a waiver. The trail is narrow at spots and is in
 need of repair due to erosion, tree damage, and age. Two culverts will
 be needed to prevent storm water erosion. The application will be in
