The Public Works Department would like to initiate the purchase process for a budgeted 1 ton pickup truck.

The FY2018 budget allows \$43,705 for a 2017 F350 to replace the 2002 F450 that was involved in an accident in January of 2017. We received \$12,291.67 from LGIT for an insurance claim payment for the totaled vehicle.

The replacement vehicle will be equipped with a snow plow and salt spreader to provide additional coverage for the snowplow crews.
